The purpose of this letter is to clarify matters set out in the assurance report. It is not an assurance report and is not a substitute for the assurance report.

Instituto Totum was engaged to conduct an independent verification of the greenhouse gas (GHG) emissions reported by Marfrig Global Foods S.A. This Verification Statement applies to the related information included within the scope of work described below. The determination of the GHG emissions is the sole responsibility Marfrig Global Foods S.A. Instituto Totum sole responsibility was to provide independent verification on the accuracy of the GHG emissions reported, and on the underlying systems and processes used to collect, analyze and review the information.

## Level of Assurance

This Verification Statement was prepared to offer a limited assurance determination that covering the direct emissions of the following activities:

Scope 1: Stationary combustion, mobile combustion, fugitive emissions, solid waste, agricultural activities and effluent treatment.

Scope 2 (Location-based) and (Market-based): Acquisition of electricity.

Scope 3: Transport and distribution (upstream), waste generated in operations, business travel, employee commuting (home-work), purchased goods and services and fuel and energy-related activities not included in scope 1 or scope 2.

Reported by Marfrig Global Foods S.A. at the organization level to a possible materiality of 5%.

## Assurance Opinion

Based on the process and procedures conducted, Instituto Totum concludes that the Scope 1, Scope 2 and Scope 3 GHG emissions assertion shown above:

- There is no evidence that the Marfrig Global Foods S.A. greenhouse gas inventory for 2024 is not materially correct, is not a fair representation of GHG data and information and has not been prepared in accordance with the Specifications of the Brazilian GHG Protocol of Accounting, Qualification and Publication of Corporate Inventory of Greenhouse Gas Emissions (EPB).
- It is our opinion that Marfrig Global Foods S.A. has established appropriate systems for the collection, aggregation and analysis of quantitative data for determination of these GHG emissions for the stated period and boundaries.
