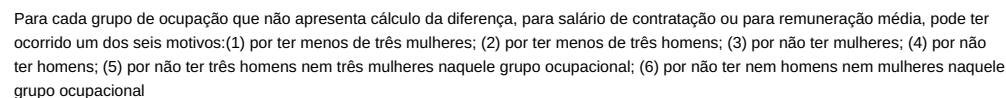

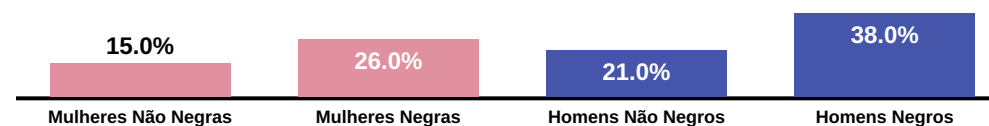
Composição do total de empregados por sexo e raça/cor



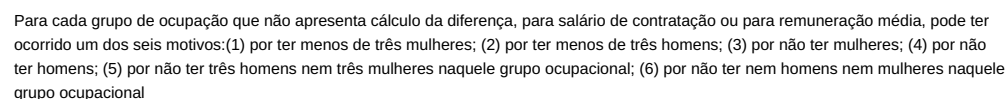

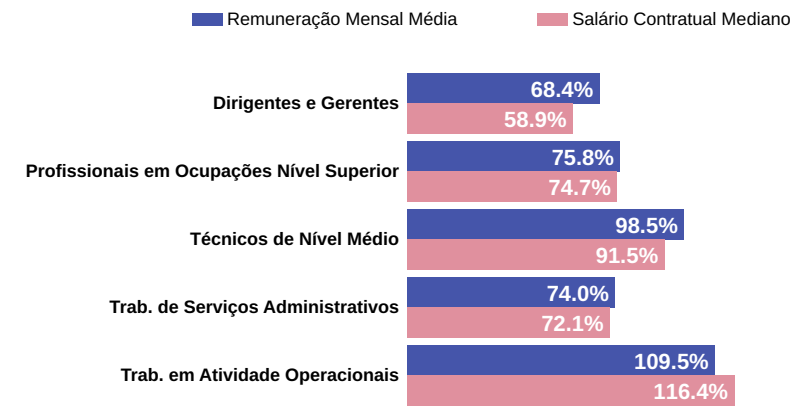

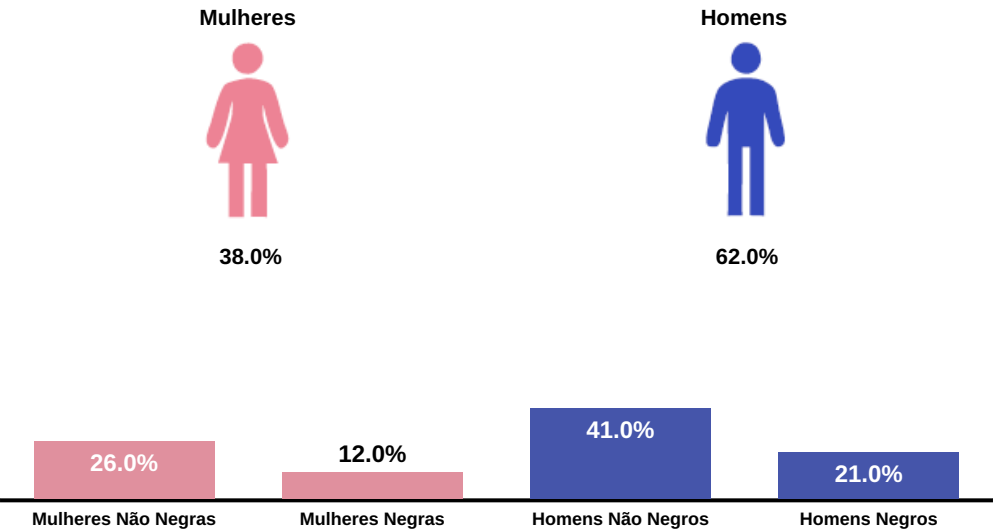

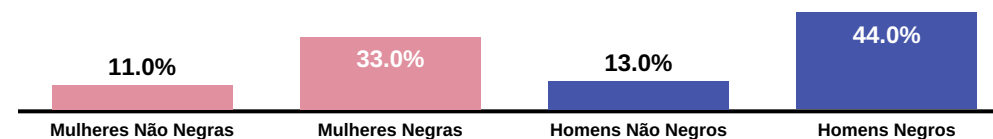

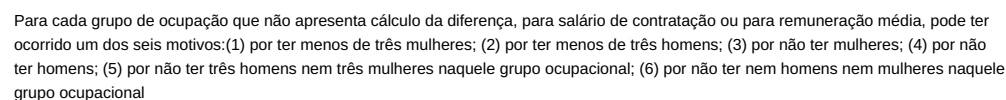
